



Bottom View (Bumps Up)










Figure 1. ESD Clamping Voltage Screenshot Positive 8 kV Contact per IEC61000-4-2





Figure 2. ESD Clamping Voltage Screenshot Negative 8 kV Contact per IEC61000-4-2




Figure 7. Tape and Reel Mechanical Data

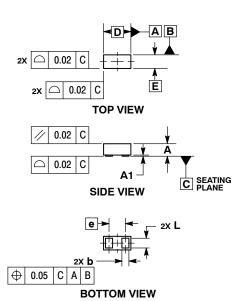

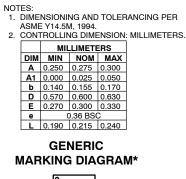

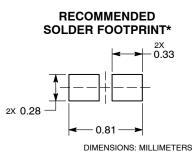
